#### **ENROLMENTS**

#### **BOOKINGS AND CANCELLATIONS**

Once enrolled, two weeks notice is required for cancellation of permanent bookings, 24 hours for casual bookings. Cancellations within this period will incur the 50% fee of the full fee.

#### **BEFORE & AFTER SCHOOL CARE**

Bookings can be made online any time up to 24 hours before the session commences. To make a booking after this time, please contact your Service directly, on the mobile number provided upon enrolment.

#### MEDICAL AND BEHAVIOUR MANAGEMENT PLANS

So we can provide the best and safest care, it is important that you inform the service if your child has an identified health care need, allergy or relevant medical/behavioural condition diagnosed by a registered medical practitioner.

Prior to your child's first day discuss with us your child's medical/behavioural support needs and plans. All medications (including ointments and creams) must be prescribed by a medical practitioner, be in the original container with original pharmacist labels and clear instructions. All labels must be legible and undamaged, and the medication must still be within its expiry date.

#### LATE PICK-UP

A Late Fee is charged for late collect of children from After School and Vacation Care, the fee is \$20 for the first 5 minutes and \$2 minute after that. CCS is not applied to Late Lees.

#### **STATEMENTS AND PAYMENTS**

Invoices are sent out weekly via the Kidsoft Parent Portal. Payments can be made via the Parent Portal by either setting up a Direct Debit Option, or setting up your Bank Account Details to make One-Off Payments that you can manage yourself.

#### **VACATION CARE**

Vacation Care Activity Calendars are distributed during Week 5 of each term and include a range of fun activities, incursions and excursions. Bookings can be made via the Parent Portal or via emailing enrolments@ccel.com.au. Our Vacation Care programs are operated at our larger Services in close proximity to smaller Services to provide access for all.

#### **CHILD CARE SUBSIDY (CCS)**

Fees for care are eligible to be reduced by CCS, many families are eligible for Child Care Subsidy, which can reduce the cost of Outside School Hours Care by up to 85%. All our services are CCS approved, so we encourage all families to find out whether they are eligible. To establish what level of CCS you may be entitled to please contact the Centrelink Family Line on 13 61 50.
